



IMPORTANT ACCUPRIL 10 MG, 20 MG, 40 MG TABLET RECALL NOTICE

Dear Member,

Your health is important to us. On **April 22, 2022** the U.S. Food and Drug Administration (FDA) announced a drug recall notice. It is for **specific** lots of Pfizer's **Accupril 10mg, 20mg and 40 mg tablets**.¹ The FDA issued the recall because the product may have a safety concern.
