

**IMPORTANT RECALL NOTICE FOR
FENTANYL TRANSDERMAL SYSTEM 25 MCG/H**

Dear Member,

Your health is important to us. On **January 31st, 2025**, the U.S. Food and Drug Administration (FDA) announced a drug recall notice. It is for **one lot of Fentanyl Transdermal System 25 mcg/h from Alvogen, Inc.**¹ The FDA issued the recall because the product may have a safety concern.
