Partnering for Quality Care: HEDIS® Medical Records Collection Project Season is Here!

Your participation in the Healthcare Effectiveness Data & Information Set (HEDIS®) project is essential for meeting regulatory requirements and improving member care. HEDIS® measures help assess healthcare performance while ensuring HIPAA compliance (45 CFR 164.512).

From February to May, Doctors HealthCare Plans, Inc. (DHCP) will be collecting data from your office for services rendered in Measurement Year (MY) 2023 that were not captured through claims or supplemental data. We kindly request your support by providing the required medical record information in alignment with annual HEDIS® technical specifications. Your participation in the Healthcare Effectiveness Data & Information Set (HEDIS®) project is essential for meeting regulatory requirements and improving member care.

Enhancing Patient Care through Medication Adherence: A Focus on CMS STAR Measures

Medication adherence is essential for managing chronic conditions and improving CMS STAR Ratings. Your role in supporting patients with consistent medication use significantly impacts health outcomes and plan performance. This article highlights the three CMS adherence measures and steps you can take to ensure a Proportion of Days Covered (PDC) rate of 0.80 or higher.

WHY MEDICATION ADHERENCE MATTERS

- **Better Outcomes:** Reduces complications like heart attacks, strokes, and diabetic crises.
- **Higher STAR Ratings:** A PDC rate of 0.80 or higher boosts overall STAR scores.
- Lower Healthcare Costs: Reduces hospital admissions and emergency room visits.

KEY CMS ADHERENCE MEASURES

- Cholesterol (Statins): Consistent statin use to reduce cardiovascular risks.
- Hypertension (RASA Inhibitors): Control blood pressure to lower stroke and heart attack risks.
- Diabetes (Oral Medications): Maintain blood sugar control and prevent complications.

BEST PRACTICES FOR ADHERENCE

- Med Sync: Align refill dates.
- 100-Day Fills: Recommend longer prescriptions.
- Patient Education: Explain medication benefits and address concerns.
- Side Effects: If members are suffering from sideeffects, discontinue medication at the pharmacy and note it in members chart for the future.
- Pharmacy Collaboration: Partner with pharmacists for monitoring and medication delivery options.
- Follow-Up Visits: Conduct regular check-ins to ensure adherence.

Improving adherence is a shared responsibility. By focusing on these measures, we can achieve better patient outcomes, boost STAR ratings, and create a more efficient healthcare system. Thank you for your commitment to exceptional patient care. Together, we can achieve better health for 100-Day Prescriptions: Suggest 100-day supplies to minimize gaps in therapy.

New Part D Star Measure -Concurrent Use of Benzodiazepines and Opioids (COB)

The opioid crisis remains a critical public health concern, fueled in part by the concurrent use of benzodiazepines and opioids. This combination accounts for over 30% of opioid-related deaths and leads to increased emergency visits and hospital admissions. Research shows that the risk of overdose death rises more than fivefold within the first 90 days of concurrent use.

MEASURE DESCRIPTION: The measure tracks the percentage of individuals aged 18 and older with concurrent prescriptions for opioids and benzodiazepines. A lower rate indicates better performance.

PROVIDER ACTION REQUIRED: Evaluate your patients currently prescribed both opioids and benzodiazepines. This combination is now recognized as a Part D Star Measure for MY2025 due to its high-risk potential.

EXCLUSIONS: Patients are excluded from this measure if they have any of the following during the measurement year:

- Cancer
- Hospice or palliative care
- Sickle cell disease

CLINICAL RECOMMENDATIONS:

- Risk Assessment: Evaluate patient risks before initiating opioid therapy.
- Non-Opioid Alternatives: Use non-opioid treatments such as physical therapy or cognitivebehavioral therapy when possible.
- Evidence-Based Guidelines: Follow established protocols for safe and effective pain management.

TIPS FOR SUCCESS:

- Discuss Treatment Options: Explain the benefits, risks, and availability of non-opioid therapies.
- 2. Coordinate Care: Communicate with all treating providers to avoid co-prescribing.
- 3. Follow CMS Co-Prescribing Guidelines:
 - **Avoid Initial Combination: Use** alternative treatments where possible.
 - Limit Dose & Duration: Prescribe the lowest effective dose for the shortest time.
 - Taper & Discontinue: Gradually taper and discontinue long-term medications when feasible.
 - Monitor Closely: Continue long-term co-prescribing only when essential, with regular monitoring.
 - Provide Rescue Medication: Offer naloxone to high-risk patients and caregivers to reduce overdose risks.

By following these guidelines, you can help improve patient safety, reduce opioid-related risks, and enhance care outcomes. Together, we can save lives.

100-Days' Supply for Star Measure Drugs in 2025

Doctors HealthCare Plans will now allow a 100-days' supply of the following medications listed below.

Prescribing a 100-day supply can help improve Medicare Star Ratings for medication adherence for statins, hypertension or oral diabetes medications.

Please consider prescribing these medications for a 100-days' supply, where appropriate. The member will pay 3 copayments just as they would for a 90-days' supply.
